

# Wedmore Scout Group Consent Sheet



## Protecting your child's personal data & images

The General Data Protection Regulations and the Data Protection Act cover the protection and processing of personal data, some of which is classed as 'Sensitive Personal Data', and covers computer based, as well as paper based information. To hold this 'Personal Data', and other details within our records, we need your explicit approval. In a Scouting context this may include information about your child's:

- contact information – so that we can get hold of you, should we need to do so
- health & well-being - so that we are prepared for medical emergencies
- disabilities - to make sure that your child's participation in activities is safe
- religious or similar beliefs - to help us to make appropriate arrangements, when necessary
- racial or ethnic origin – so that we are sensitive to their cultural needs

The Group uses the internet based 'Online Scout Manager' to hold these records (this has the required level of security), and will only keep them for as long as is required. None of the information held by the Group will be disclosed to third parties outside the Scout Movement, without your consent. **You can check these details to ensure that they are accurate and up-to-date, by using the 'My.Scout' facility.**

Sometimes photographs, digital and/or video images of Members of Wedmore Scout Group taking part in activities are used within the Scout Group, in District or County Newsletters and/or websites, are submitted to the local newspapers, or are put on display. However, when this is done, the individual's name is not linked to the picture. To store and use these types of images of your child we need your explicit consent.

## Newsletters

Occasionally, the Group issues Newsletters, and/or other e-mail communications, to keep you informed of developments and/or events taking place in the Group. The Group need your explicit consent to issue these to you.

## Gift Aid Donation

If you pay Income Tax, please participate in the Group's Gift Aid Scheme, which allows the Group to reclaim tax on any qualifying donation and/or subscription made in the past four years, as well as all future gifts of money that you make; regardless of whether it is regular payment or a one off. **It is important that the declaration below is completed by the person who will pay the members subscriptions.**

This is not a legal document and does not ask you to commit to paying the membership subscription for a set period. Please notifying the Group if you:

- Want to cancel this declaration
- Change your name or home address
- No longer pay sufficient tax on your income and/or capital gains
